## **ENVIRONMENTAL AND SOCIAL COMMITMENT PLAN**

- 1. The National Planning Authority (NPA) is implementing the "Support to National Planning Capacity Building and Greater Kampala Metropolitan Area Economic Development" (the Project). This Technical Assistance will support two components, Component 1.1 supports the National Spatial Planning Capacity and Component 1.2 supports the Greater Kampala Metropolitan Area (GKMA) Economic Development. The National Spatial Planning Capacity support covers (i) publicizing and raising awareness of the Uganda spatial development initiative, (ii) developing and adopting the standards that will guide spatial data capture, storage, integration, analysis and output, (iii) coordinating spatial data use and sharing for consolidation, and integrated planning, and (iv) building institutional capacity in spatial data analysis and use. The support to Greater Kampala Metropolitan Area (GKMA) Economic Development covers (i) enhancement of the capacity of the Greater Kampala Metropolitan Area urban institutions in the areas of Public Investment Management, (ii) undertaking feasibility study for the Greater Kampala Tourism Circuit project, and (iii) preparation of the land banking guidelines to operationalize the National Land Policy. The International Bank for Reconstruction and Development/International Development Association (the "Bank"), acting as administrator of grant funds under the Partnership for Support to the Implementation of Uganda's National Development Plan II Multi-Donor Trust Fund, has agreed to provide financing for the Project.
- 2. NPA will implement material measures and actions so that the Project is implemented in accordance with the World Bank Environmental and Social Standards (*ESSs*). This Environmental and Social Commitment Plan (*ESCP*) sets out a summary of the material measures and actions.
- 3. NPA will also comply with the provisions of any other E&S documents required under the ESF and referred to in this ESCP, such as Environmental and Social Management Plans (ESMPs), Resettlement Action Plans (RAPs), Indigenous Peoples Plans (IPPs), and Stakeholder Engagement Plans (SEPs), and the timelines specified in those E&S documents.
- 4. NPA is responsible for compliance with all requirements of the ESCP even when implementation of specific measures and actions is conducted by the Local governments, agency or unit referenced in 1. above.
- 5. Implementation of the material measures and actions set out in this ESCP will be monitored and reported to the Bank by NPA through NPA as required by the ESCP and the conditions of the legal agreement, and the Bank will monitor and assess progress and completion of the material measures and actions throughout implementation of the Project.
- 6. As agreed by the Bank and NPA, this ESCP may be revised from time to time during Project implementation, to reflect adaptive management of Project changes and unforeseen circumstances or in response to assessment of Project performance conducted under the ESCP itself. In such circumstances, NPA, will agree to the changes with the Bank and will update the ESCP to reflect such changes. Agreement on changes to the ESCP will be documented through the exchange of letters signed between the Bank and the NPA. The NPA will promptly disclose the updated ESCP. Depending on the project, the ESCP may also specify the funding necessary for completion of a measure or action.
- 7. Where Project changes, unforeseen circumstances, or Project performance result in changes to the risks and impacts during Project implementation, NPA shall agree on the best way feasible to solicit financing needed to implement actions and measures to address such risks and impacts.
